  - Lack of other dependency system of care partners /education to line staff.




- <u>Politics</u>, integration, **funding**, access, voice, silos, **competition**, contracts, relationships, stigma, oppression, cultural genocide.

- I continue to feel as though we have not clearly identified/messaged our North Star and the throughline of the action teams, core group, etc.
- Continuing to <u>co-create with those impacted</u> to learn from them about what <u>needs to</u> <u>change and using that to create strong</u> <u>messaging and direction.</u>
- I think the greatest opportunity in 2024 is to start developing and creating. This will involve deciding what 1 or 2 areas that TFSC FL can have the most impact and intentionally working on those







How has TFSC cultivated concrete ways to authentically support families?

- <u>Just beginning the conversation</u> about prevention has led to concerns and challenges being addressed differently.
- What I got a taste of in one meeting was that each group brings important insights and are working hard and that is inspiring to me.
- <u>Developed culture, momentum</u>, formalized charter and team, delivered workshops and community planning/forums, <u>engaged</u> <u>parents and youth leaders at the table and in leadership</u>, integrated a small community of champions across FL and the allies across Nation.

- Through advocacy and education about prevention services and what is available.
- We are in the process of cultivating ways to support families.
- We have <u>a good representation of impacted parents</u>, and more recently youth, in the discussions. I don't know if we have yet cultivated concrete ways to authentically support families outside of our small TFSC team.

- Having lived experts a part of the call allows for those perspectives to be included and giving way on the best approach to support.

How has TFSC led to a deeper relationship in communities and neighborhoods?

- Has begun to help breakdown communication and silo mentality barriers.
- By voicing parent's rights.
- Movement has allowed for collaboration between circuits and counties for trauma responsive/informed best practice sharing.
- We have not done much here; I would describe it as we are in the planning operation of this work i.e. we have begun to work the soil and planted a few seeds.
- Collecting data to send a clear message of services and the impact that prevention agencies are making.

# How has TFSC led to a deeper relationship in communities and neighborhoods?

- We can do better in Florida. Not everyone is aware of the mission of the movement.
- I don't know if we have yet established a deeper relationship in communities and neighborhoods outside of our small TFSC team. I think we have challenged each other to do this individually, but we have not scaled this.
- I don't think it has.
- I don't think this has happened yet.



- Meetings go by fast, and there is not much time to complete tasks after our check-in. We should consider extending our time.


### What other suggestions or feedback would you like to share?


